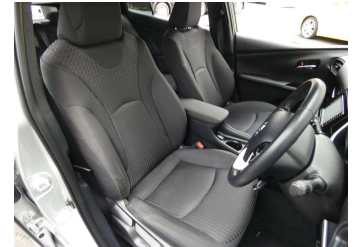

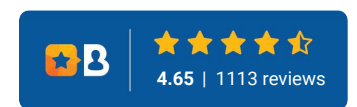

These are an account admin fee of \$4.00 per month (other payment frequencies may be available) and a one-off establishment fee of \$510.35. The total amount of repayments has been calculated by multiplying 208 weekly repayments (based on a 48 month term) by the weekly repayment amount of \$100.50 which equals \$24,799.99.
